

Coverage Information

We are here to assist you in selecting the coverage protection that best suits your needs. When preparing to relocate and store with Booth Movers, Ltd., it is important to consider the following items:

- Unless a greater value is declared by the owner/shipper or authorized agent, the goods are released to the moving company at a value of \$.60 per pound, per article; **this is provided at no additional cost.** Please note that under these provisions, a 100-pound television valued at \$1,000.00 is covered to a maximum of \$60.00.
- **Additional transit coverage** may be purchased through Booth Movers, Ltd. at a cost of \$8.00 per \$1,000.00 of coverage. For more information, please contact our office prior to your relocation.
 - The **minimum valuations** listed below apply for all additional transit coverage:
 - Private Home: \$40,000.00
 - 1-Bedroom Apt.: \$15,000.00
 - 2-Bedroom Apt.: \$20,000.00
 - 3-Bedroom Apt.: \$25,000.00
- **All coverage has a \$500.00 deductible assumed by the customer.**
- **All claims must be made in writing and received within 90 days of initial relocation date.**
- To properly cover the total value of your goods, you must cover the **full** value of all goods to be relocated; anything less might result in **proportionally less coverage.** For example, \$20,000.00 worth of goods covered at \$10,000.00 results in 50% coverage of damaged goods.
- **Maximum value** (coverage) not to exceed \$100.00 per pound, unless items noted in writing by customer prior to relocation.
- **Jewelry and cash are not covered.** Please relocate them yourself.
- All coverage **will not include** lamps, pictures, bric-a-brac, plants (& pots) and cartons packed by the owner, shipper or 3rd party. These items are only covered if packed in cartons by Booth Movers, Ltd. and additional coverage is purchased.
- All coverage is based upon the **depreciated (current) value** of the goods.
- The amount and type of coverage purchased will be indicated on the ~~W~~Order for Service;+please verify all figures.
- **Minor damages** such as nicks, dings and scratches will not be repaired unless additional transit coverage is purchased. In addition, Booth Movers, Ltd. has the right to repair damages deemed repairable by a professional restorator. All items damaged must be held until settlement is reached.
- No mechanical/electronic items covered unless there is evidence of external damage.
- Your **present homeowners or tenant rental insurance** policy may extend coverage to your goods while stored or in transit. Check with your insurance agent for further information.
- **Depository insurance** (for storage and handling in & out of storage) must be purchased through Booth Movers, Ltd. at a cost of \$4.00 per \$1,000.00 of coverage, per month. For more information, please contact our office.
